

## INSTRUCTIONS TO AUTHORS

### *Agricultural Economics (Zemědělská Ekonomika)*

The journal publishes original scientific papers, short communications, up-to-date review articles, and selectively book reviews from the disciplines concerned. Papers are published in English. After acceptance of the manuscript it is necessary to pay the Manuscript Handling Fee (200 EUR/article with VAT). Manuscripts should have English abstracts (including keywords). The author is fully responsible for the originality of the paper and its subject and formal correctness. Original papers should not exceed 28 000 characters (without space) (including tables, references, and figure captions). Manuscripts have to be spell checked. The author's declaration that the paper has not been published anywhere else should be enclosed. The Board of Editors decides on the publication of papers, taking into account peer reviews, scientific importance, and manuscript quality. The manuscript should be submitted by the website:

**Copyright.** The journal is protected by copyright held by the publisher after the manuscript has been accepted for publication. As concerns the transfer of rights, the corresponding author takes over responsibility for all authors. No part of this publication may be reproduced, stored, or transmitted in any form or by any means, without the written permission of the publisher.

**Manuscript layout.** MS Word editor should be used for creating the text (font Times New Roman) type size 12 font, 1.5-space lines. Tables and graphs are to be submitted separately to the text include its title and measurement units used should be indicated. We request that submissions are comprised of the following separate editable files: (1) **manuscript in MS Word (.doc format)**, (2) **tables in MS Word (.doc format)**, (3) **graphs in MS Excel (.xls data files)**, (4) **photographs in .jpg/.tiff format** (at least **300 dpi** resolution), (5) All graphs and photos should be numbered, continually according to the order in which they are included in the text, again using Arabic numerals. All other material should be submitted in digital form and publication quality. All material to be included in a paper should be referred to in the text. Duplicated documentation of data in both Tables and Figures is not acceptable. If any abbreviations are used in a paper, they shall be explained appropriately when they are used in the text for the first time. It is not advisable to use any abbreviations in the paper title or in the abstract.

**Paper title** should be short, intelligible, not exceeding 85 characters. No subtitles shall be used.

**Abstract** is a short summary of the whole paper including an outline of the objective, method, results and conclusions of the paper, but it should not be a mere description. It should describe all essential facts of a scientific paper and basic numerical data including any statistical evaluation should be incorporated in the abstract. Keywords must be included. The abstract should not go to more than 200 words. Stylistically, whole sentences, not slogans, should be used. The abstract is an important part of the paper because it is published and cited in world databases.

**Introduction** should outline the main reasons why the research was conducted, demonstrate knowledge of the subject in question as described by a brief review of literature exclusively consisting of refereed periodicals, journals and books, and the goal of the authors.

**Material and Methods.** All preliminary material, experiments conducted, their extent, conditions and course should be described in detail in this section. All original procedures that were used for the processing of experimental material and all analytical methods used for evaluation should also be detailed. Data verifying the quality of acquired data should be indicated for the used methods. The whole methodology is only to be described if it is an original one, in other cases it is sufficient to cite the author of the method and to mention any particular differences. Methods of statistical processing including the software used should also be listed in this section.

**Results and Discussion.** Results obtained from the experiments, including their statistical evaluation and commentary should be presented graphically or in table-form and the author should comment on the results and confront them with data published elsewhere.

**References** in the list are arranged in alphabetical order by the surname of the first author. The list of references should not exceed 25 references. The surnames and initials of all the authors, separated by a comma, should be followed by the year of publication in parentheses, the title of the paper in English, the full title of the periodical,

volume, and page numbers. With a book or proceedings, the title should be followed by the name of the publisher and the place of publication and, if not originally in English, by the language of publication given in parenthesis – e.g. (in Czech). Only papers cited in the text should be included in the list of references. All names of the authors must be given in English transcription without national-specific letters. Authors are responsible for the accuracy of their references. If more than one paper by the same author(s) published in the same year is cited, the papers should be differentiated by YEAR a, b, c both in the text and the list of References. Author name(s) and year of publication are to be cited by including them in the text directly, e.g. “... as published by Roberts (2013)” or indirectly – citing name(s) and year of publication in parenthesis (Ahlin and Lin 2006), (Berger et al. 2006). Several papers cited together should be arranged according to the year of publication starting with the oldest one.

**The Authors' Address.** On a separate page the author should include his or her full name (co-authors' full names), including all academic, scientific and pedagogic titles and detailed address of the institution with postal code, e-mail address. The author who is responsible for any correspondence with the journal should be clearly indicated.

**Contact address** should include the postal and e-mail addresses of the corresponding author.

**Offprint:** Every author whose e-mail address is published will receive a **free “electronic reprint”** in Portable Document Format (pdf) sent via e-mail as an attachment. Free reprints are also available on the website
